8	At a scale of 1 inch = 12 nautical miles, draw a hypothetical sinuous (i.e., curvy) coastline and construct the territorial sea limit. Include the following:  1) a closing line for a bay which is 13 nautical miles wide at its mouth,  2) a drying rock which is 6 nautical miles off the coast,  3) a drying rock which is 15 miles off the coast,  4) a string of small islands parallel to the coast.	8	
9	Article 76 of the UN Convention on the Law of the Sea enumerates several parameters to define the outer limit of the continental shelf. Draw as many simplified cross-sections of the continental margin as necessary, each cross-section illustrating a different parameter controlling that outer limit.
