

# The First David Thompson National Geomatics Awards

Celebrating excellence in the field of geomatics in Canada, the Association of Canada Lands Surveyors (ACLS) introduces the new David Thompson National Geomatics Awards Program. The program is developed in cooperation with all professional surveying associations across Canada through the Canadian Council of Land Surveyors (CCLS). The inaugural awards will be presented at the Gala Dinner of the National Surveyors' Conference on June 22 at the Loews Le Concorde Hotel in Québec City, Québec. The deadline for submissions is March 30 each year. Since this year was the first, we extended the deadline to April 6.

Awards will be presented for the following categories:

- Innovation in Geomatics
- Contribution to Society
- Unusual Applications in Geomatics



All commissioned surveyors, who are members of a Canadian surveying association, and who submit projects that have been completed within the last three years are eligible.

If you missed the deadline this year, you will have another chance next year.

**David Thompson** was an explorer and surveyor who almost single-handedly mapped Canada's vast, unknown interior 200 years ago. He covered 80,000 miles by foot, horseback, dogsled, and canoe, defining a fifth of the continent, compiling 77 volumes of journals about its geography, biology, and ethnography. Equipped only with a brass sextant, he made maps that rival images from today's satellites. Some say that he was the world's greatest land geographer. # **Executive Director's Notes**

# The ACLS Wins its First Illegal Practice Case

On May 10<sup>th</sup>, 2006 a Québec Land Surveyor, who does not hold an ACLS licence, pleaded guilty for illegal practice of cadastral surveying on Canada Lands. It's a first for the Association of Canada Lands Surveyors.

We obtained a copy of a certificate of location prepared by the defendant showing a property within the limits of an Indian Reserve in the Province of Quebec dated April 19, 2005. Council passed a motion to institute penal proceedings against the defendant for violation of section 64 of the Canada Lands Surveyors Act on November 3<sup>rd</sup>, 2005. The case was heard in Criminal Court on May 10, 2006. The ACLS finally received copy of the decision on September 15<sup>th</sup>, 2006. The defendant was fined \$500 since it was a first offence.

### **Preparation of Bilingual Survey Plans**

We recently have been made aware that ACLS licence holders have been submitting bilingual plans where the translation was of poor quality or the terms were inconsistent between the two language versions.

Some clients (e.g. Parks Canada) require that survey plans be submitted in both official languages. We would like to remind you of the following paragraph of the CLS Code of Ethics (section 3 of the *Canada Lands Surveyors Regulations*):

Paragraph (7): Members shall maintain their competence, integrity and respect for their profession in their relations with colleagues, clients, employers or employees and the public and shall, in particular,

(*h*) refrain from accepting assignments beyond their competence or beyond the resources available to them

So if you do not have command of the second language, be sure you have access to qualified translators before accepting such survey projects.

#### **Public Awareness**


A reminder that the PowerPoint presentation is available from the ACLS Web site. It's designed to allow flexibility to address different target audiences (from students to realtors, for example).

# Summary of Council Meetings

# September 7, 2006, teleconference meeting

- Council formed the Gala Awards Task Force with the mandate to organize and deliver a Gala Awards Night at the June 2007 National Land Surveyors Conference in Quebec City. Furthermore, Council approved a budget of \$2000 to support this event, under the premise that as many funds as possible be recovered from sponsorship.
- Appointment of most members of ACLS Committees.
- Reappoints Marie-Christine Robidoux for another 5 year mandate as member of the Board of Examiners.
- Approval of the ACLS 2005-2006 Annual Report.
- Agreement in principle to hold the year 2008 National Surveyors' Conference in Victoria B.C. in joint venture with the Canadian Hydrographic Conference.
- Renewal of Jim Gunn's contract as the ACLS Practice Review Manager for another 2 years.
- Council passed a motion to instruct CIBC Wood Gundy to close the Practice Review Fund and transfer all funds to the ACLS General Reserve Fund.

- Approval, in principal, of a second tier (non CLS) of the proposed model for the certification of hydrographers.
- Approval of the CCLS Memorandum of Understanding on Distance Learning.

# November 30<sup>th,</sup>, 2006, face-to-face meeting in Canmore, Alberta

- Approval of Policy 06-01 on the new requirement for permit holders to have Surveying as a Principal Function because of the coming into force of the new section 33 of the CLS Regulations.
- Approval of policy 06-02 on the new requirement for permit holders to have an ACLS license holder as a member of the management team again because of new section 33.
- Appointment of remainder of ACLS committee and task force members.
- Approval of the new Offshore Issues Committee Terms of Reference.
- Council directed the Executive Director to pursue discussions with CCLS on the National Conference and Awards Gala initiatives.
- Following the signature of the MOU with the Royal Institute of Chartered Surveyors, Council appointed J.C. Tétreault to represent the ACLS in this new relationship.

# February 6<sup>th</sup>, 2007, teleconference meeting

- CLS Commissions will be offered to Michael Barry, Mackenzie Lee, Robert Pinkerton, Sandra Wards, Jean-Sébastien Harvey, Ronald J. Stewart, Nathalie Brousseau, and Andrew Morse.
- Approval of the benefit packages for the ACLS staff for 2007.
- Discussion on the Saskatchewan Land Surveyors' Association "Surveyor in a Crate" initiative:
  - This initiative is modelled after the Science Alberta Foundation "Made to Measure Crate" which has been well received in Alberta high schools.
  - In April of 2006, the ACLS sent a letter of support to the SLSA. The ACLS agreed, if certain conditions were met, to give an amount of \$8,400. ACLS would receive a physical crate and our understanding was that a circulation system would be in place.
  - Last January, the SLSA presented a new proposal to the ACLS. The ACLS would give an amount of \$8,400 and in exchange, would get access of a blue print of the "Crate". No physical crate and no circulation system.
  - So Council decided to send a letter to the SLSA asking for a copy of the request for proposal, or any other similar document that's been issued to get a proposal for the crate, as well as a copy of the proposal with the breakdown of cost and activities.
- Council approved new CLS Regulation amendments. The next step is to send them to the Natural Resources Canada for it's approval before the membership vote.
- Approval of an amendment to section 12.1 of the ACLS General Bylaws. The next step is ACLS membership approval.
- Approval of the new Aboriginal Liaison Committee Terms of Reference.
- Approval of the ACLS Levy increase to be a CCLS member.
- Approval of an increase in fee to mark ACLS exams.

# March 13<sup>th</sup> 2007, teleconference meeting

- CLS Commission will be offered to Matthew S. Smith.
- Approval of a new Section 50 of the CLS Regulations. This will be included in the package that will be sent to NRCan.
- Council approved the new ACLS Strategic Plan and Operational Plan.

# Available Scholarships

Three scholarships of \$1,500 each are available annually. One scholarship is targeted to an aboriginal student that meets the eligibility requirements. The scholarships are acknowledged at the ACLS Annual General Meeting.

# Eligibility

- 1. Eligible applicants are students in good standing, registered full time, and continuing studies in a geomatics program at a recognized University, Technical Institute or Community College in Canada.
- 2. Applicant must be a Canadian citizen or a landed immigrant.
- 3. Applicants must demonstrate a passing grade in all courses.



- Proof of Canadian Citizenship or landed immigrant status.
- If applying for a scholarship targeted for Aboriginal students, please provide evidence of Aboriginal status.
- Optional C.V. or resume, summarizing education, past employment, community involvement, etc.

An intense strategic planning update session was held in Canmore, Alberta on December 1 and 2, 2006 attended by Council members. At the end of the planning session, Council agreed on six strategic objectives which are as follows:

# **Continuing/Improving Statutory Requirements**

The ACLS will continue to assume its role as stipulated in the Act and will improve on the processes that will permit it to meet its statutory requirements. In particular in the following areas: Practice Review;

Maintenance of Standards;

Complaints and Discipline;

Continuing professional development; and

Greater involvement with the offshore.

# Public Recognition of Contribution to Economic, Social and Cultural Development

The ACLS will work towards enhancing the public image of the profession and the promotion of the socio-economic value of land tenure systems as a whole (including to Aboriginal governments).

### **Aboriginal Involvement**

The ACLS will strive to bring more Aboriginal people into the geomatics sector and in particular the CLS profession.

# Providing Value to the Expanded Profession

The ACLS will attract more non-land surveying geomatics professionals to become members of the Association. In particular people from the hydrographic community and students.

### National Responsibility and Integration

The ACLS must continue to play a key role on the national geomatics scene and continue to promote cooperation between national geomatics organizations.

#### Importance of the CLSS and the Property Rights Infrastructure to the Orderly Development of Lands and the Offshore

# WANTED: Authors to Update the Property Rights Book

Most CLS spent hours studying a book entitled "Property Rights and Boundary Systems on Canada Lands" for their CLS exams. This comprehensive piece of work was made available in 1990 with the mention "Provisional version". It is now way out of date. So the ACLS Board of Examiners is working on an updated version. ACLS obtained the copyright on the book.

The book presently has 12 chapters. Chapter 6 will not be updated since the new book entitled "Canada's Offshore: Jurisdiction, Rights, and Management" is published. A few ACLS members are presently updating chapters including a new chapter on property rights in Nunavut. We are looking for authors to update the following chapters:

- 1. NWT 22 pages
- 2. Yukon 22 pages, 5 maps and figures
- 3. Indian Lands 39 pages and 16 maps, figures and tables
- Federal Lands & Interests 12 pages and 15 maps, figures and tables

**Boundary Systems** 

- 5. Provincial & Territorial Boundaries – new Territory added
- Appendices A. Canada Centre for Cadastral Management – 14 pages and 6 tables

# **New Permit Requirements**

As was mentioned in the September issue of *Communique*, the following new section on permit requirements is now in force:

33. The Registrar shall issue a permit to an entity if

(a) a principal function of the entity is surveying;

(b) the entity has within its management at least one licence holder who ensures that the entity complies with the Association's standards of conduct, knowledge and skill in its surveying activities; (c) the entity has professional liability insurance coverage at least equivalent to that required by licensed members under subsection 29(4);

(d) the name of the entity is not misleading, self-laudatory or inappropriate with regard to protection of the public and the integrity of the profession; and

(e) the application complies with the requirements of the Act and these Regulations.

Since this is new, we asked for some additional documentation for renewal of ACLS permits. To ensure that one of entity's activities is surveying, we asked for one of the following documents:

- In the case where an entity is a corporation, a copy of the official corporate documents that set out the business activities that the entity can undertake (the "objects" of the corporation).
- In the case where the entity is a partnership, a copy of the parts of the partnership agreement that sets out the business activities that the partnership can undertake.
- In the case where an entity is an unincorporated organization or association, a copy of the parts of the organizational documents that specify what business activities will be performed by the entity.

The submission should include those documents that clearly state that surveying is one of the functions of the entity.

To ensure that entities (1) have at least one ACLS licence holder amongst its senior management staff; (2) the licence holder is involved in the decision making process as it relates to surveying activities on Canada Lands; (3) the licence holder has actual authority and means within the entity to control surveying activities on Canada Lands, we asked for the following documents:


- In the case of an incorporated or limited company, an official list of the members of the Board of Directors which includes at least one licensed ACLS member (for example it could be a copy of the most recent annual return to Corporations Canada if federal);
- An organization chart;
- Job description of the licensed CLS(s);
- Any other document illustrating the licensed CLS's responsibilities.

If the CLS(s) is (are) member(s) of the Board of Directors, the CLS(s) is(are) deemed to have sufficient authority for the purpose of section 33(b). If some of the requested documents do not exist, then an affidavit or statutory declaration signed by the Chief Executive Officer and the licensed CLS(s) declaring that the CLS(s) has (have) full authority and means to control surveying activities on Canada Lands is deemed sufficient.

Unfortunately, only a minority of firms did provide the required documents. Permits cannot be renewed without this documentation. If you are one of those who did not yet send your documents and haven't received a reminder letter already, you will receive one soon.
