12	On the presumption that global warming will reduce the thickness and extent of the polar ice, how will the following activities affect Canada Lands Surveyors: a) offshore oil exploration and exploitation, b) shipping, c) international boundary determination.	6	
13	There is a real, unresolved, international maritime boundary situation where there are two States situated side by side with a relatively straight coastline across the front of the two States. No other States affect the maritime boundary scenario. Thirty (30) kilometres seaward of the terminus of the land boundary there is a small island which is one (1) kilometre in diameter, is edged by 30-metre cliffs, and could support human habitation. The island's sovereignty is not in dispute, but a military unit of that State occupies the island. Describe possible boundary solutions, preferably ones based on previous international court cases.	8	
14	What are the roles of the Canadian Hydrographic Service and the Geological Survey of Canada in the preparation of Canada's submission to the United Nations' Commission on the Limits of the Continental Shelf for a continental shelf that extends beyond the 200 n.m. limit?	6
