### 4. Ontario Regional Office/SGB Report

Report presented by Cindy Kliaman, Manager, Ontario Regional Office, SGB.

- The Toronto office is moving in June to 655 Bay St, 3<sup>rd</sup> Floor. Contact numbers could change and formal notice will go out.
- Presently, all paper files are being scanned as part of government initiative to reduce our footprint. In the meantime, there could be a delay in search times.
- E-signatures expire after 1 year so contact Cindy to renew.
- Changes are happening with the plan review section as per recent ACLS notice. Cadastral Services East and West are being combined into the Survey Regulation and Standards unit (SRS). Your plans could be reviewed by a person in the Edmonton office or in the Ottawa office. By the end of 2018, all digital plans will be signed in Edmonton (Andrew Brebner) but mylars will be signed in Ottawa.
- Provincial Plans should no longer be submitted in mylar. The can be submitted
  as 'scaled digital drawing' in tif or pdf format so the can be digitally approved,
  signed and recorded.
- Many retirements at SGB so lots of changes. .Jean Gagnon is the Surveyor General since last July. Jan Wentzel retired Dec 28<sup>th</sup>, 2017. Sylvain Lelièvre is his replacement but role is changing due to SRS.
- New budget has big impact on FNLM work. Hiawatha, Big Grassy and Chiefs Pointe are on the list.
- Flood easement work in the Rainy Lake and Lake of the Woods Area for 30+ reserves will becoming up.


### 9. Examination Enhancement Project (EEP)
