

# 6. President's Annual Report

Presented by Tania Bigstone.

T. Bigstone expresses her enthusiasm regarding the high number of attendees for this year's AGM, managing to acquire representatives from each association across Canada.

Alike all AGMs in past years, preparation has been challenging and it is important to recognize the significant amount of planning and prep work that was required to ensure this event be carried out successfully.

- T. Bigstone welcomes all members in attendance to this highly anticipated event in Canada's beautiful capital region of Ottawa, ON. A variety of engaging seminars and activities have been organized to truly encompass the excitement and anticipation of the first ever AGM supported by the Association of Canada Lands Surveyors with members of the Association of Ontario Land Surveyors and the Association of Quebec Land Surveyors.
- T. Bigstone highlights the ACLS staff and Council's various activities and accomplishments from this past year :

# **Hydrographic Certification:**

The ACLS began implementing and accepting applications for the Hydrographic Certification Program in November 2016. This process required additional work in order to update the existing Hydrographic Surveying exam and improve candidate materials. Currently there are 4 applicants working towards becoming certified hydrographers. Council is currently looking at ways to incorporate and ensure the inclusion of the Hydrographic members into the activities of Council and the Association.

# **ACLS Website revamp:**

There have been several comments from both members and non-members regarding the challenges associated with navigating through the current ACLS website. That being

said, Council has approved the tender to create a new ACLS website. This website is anticipated to be completed by June 2017. A mock-up of the proposed revamped website will be presented later today.

#### **CPD** and Geo-Ed

The Association's strategic initiatives are directly linked to continuing professional development and the delivery of educational courses and materials to members as well as sister associations. GeoEd has and will continually evolve to meet the association's changing and expanding needs.

Over the last few years, we have seen the ABCLS integrate its CPD tracking systems with the ACLS's CPD system within GeoEd and we hope to have the AOLS join this process in 2017.

T. Bigstone explains that the combined efforts between the ACLS and sister associations are continually growing and evolving. This AGM is a prime example of the great relationships and co-operation between the various associations across the country. The ACLS is currently working with another association to evaluate the ways in which the ACLS can provide assistance with day-to-day and administrative type activities.

However, while the ACLS is fortunate enough to be able to assist other associations, it is important to remember to look after the vitality of the ACLS. T. Bigstone reminds attendees that J.C. Tétreault will not be with the association forever. That being said, J.C. Tétreault and his staff are working on documenting the ACLS processes to ensure that all of the corporate knowledge is recorded and that the eventual training of a replacement for J.C. Tétreault is much easier with access to this written documentation.

T. Bigstone explains that Anne Cole and J.C. Tétreault have been the primary leaders in promoting and preparing the Foreign Credential Recognition Program application. For those members who may not be familiar with the FCR program, the purpose of this project is to create a standardized process to assess candidates at the OAGQ, AOLS and CBEPS level for those candidates who do not have formalized training.

This project would be a "one stop shop" to assess the competencies of Internationally Trained Professionals and provide them with any additional information they may need, such as a list of courses to be taken if candidates require further training. T. Bigstone updates attendees on the progress of the FCR Project application, stating that the original application was returned in request for further clarification on certain items, as well as reducing the size and funding of the project. Currently an amended application is being prepared and will be re-submitted to ESDC Canada by the end of March 2017.

T. Bigstone introduces the significance of the Survey Cost Study, explaining that the issue initially arose at NSC 2015 in Winnipeg. During a presentation, numerous, unverified statements were brought forward regarding the costs of surveys on Canada Lands suggesting that surveys on Canada Lands are too time consuming and costly.

In attempt to address these unverified statements, the ACLS implemented a working group, where members from NRCan, INAC and ACLS have gathered together to brainstorm how to organize all information that pertains to verifying these statements

related to the process of conducting surveys on Canada Lands. All parties will find this information useful and it will perhaps serve as a tool to communicate and educate individuals on this topic.

Over the course of 1 ½ years, this working group has dedicated its time to the organization of information for this project. Contractor, Julia Meldrum-Smith and her husband Scott, have continually gathered and analyzed data, bringing the association closer to a completed project.

While the preliminary results will be presented and discussed further during Friday's seminar, it is important to note that the working group has managed to identify the key cost drivers for surveys – and will be able to communicate them to clients, colleagues and Government staff. T. Bigstone explains that there are cost drivers that can be shifted or adjusted and there are those that are static. There will be recommendations in which both INAC and NRCan will take back to their respective departments and will further develop ways to improve on processes and policies.

The preliminary report was received on February 22nd, 2017 and the final version will be completed before the end of March 2017.

# **Survey Capacity Study**

T. Bigstone explains that the focus of this study is to address the concerns or statements expressed which indicated the lack of a sufficient number of Canada Lands Surveyors to fulfill all surveying needs.

This study remains in its developmental stage, however, early research indicates few areas that are not in close proximity to a CLS. To assist in the gathering of data for this study, members were asked to provide the association with basic age demographics, however, there was very little participation from membership.

- T. Bigstone expresses her gratitude towards the ACLS staff, comprised of J.C. Tétreault, K. Jones, M. Reeve and T.McKay, thanking them for their continuous efforts to keep the association running smoothly.
- T. Bigstone continues to thank the members of Council, thanking them for their dedication to the association and the profession.

And last but not least, T. Bigstone expresses her sincerest gratitude to the membership, thanking them for their continuous support.

### 7. Executive Director/Registrar Report

J.C. Tétreault presents a summary of his report, which was included in the AGM report made available to attendees.

The following key points were addressed regarding the director/registrar report:

- Currently have 597 members and 121 candidates.
- The Board of Examiners is currently reviewing webinars to be presented this year and looking for instructors to present in French.

- A complaint was received and has been investigated by the complaints committee.
  It was directed to Council who decided to refer the complaint to the discipline
  committee. Currently waiting for the discipline hearing.
- GeoEd is growing rapidly, there are over 130 courses, ANSLS is the most recent addition and the association has begun to receive courses from OAGQ as well.
- Currently has 33 licensed members who have not complied with their mandatory CPD.
- Since October, MyCLSS is now allowing for members to file electronically. A tutorial on how to operate this system is available online.
- The ACLS is still offering administrative support for CBEPS.
- The ACLS finance and HR task force has been working hard since the Winnipeg AGM, they have provided recommendations to Council and are acting upon them. Still at work on finding solutions to HR and financial issues.
- The updated design for the new website was presented.

# 16. Presentation and Discussion of the Year 2017 Budget

- Decrease in the regular members and a substantial increase in licences.

- Expected more from survey related revenue.

Support needs to be increased and the need for an additional person on the ACLS staff has been identified, to accomplish this, additional revenue has to be generated through fees.

The ACLS had to deal with two complaints in 2017. Complaints Case 16-01 was closed last summer with a decision of the ACLS Discipline Committee delivered on June 23rd, 2017. The member in question, who is in private practice, was found guilty of professional misconduct and was ordered the following penalties:

- suspended licence to practice for a period of two months
- pay half of the cost of the investigation and discipline hearing
- take all required steps to fix any remaining problems with the survey that raised the complaint
- take courses in quality assurance.

The firm that employs the member, was directed to:

- pay a penalty of \$5,000
- take all required steps to fix any remaining problems with the said survey
- pay the remaining half of the cost of the investigation and discipline hearing.

The other complaint against another member in private practice was dismissed lacking any evidence of incompetence or professional misconduct following an investigation by the ACLS Complaints Committee.

# Executive Director's Report

#### The ACLS Staff

Our Communications and Members' Service officer welcome a new member of her family. Martha Reeve is a proud mother of a little baby girl called Rose who is in great health. In April we did hire Mathieu Desjardins in a temporary basis to replace Martha. Unfortunately that did not work out, so we replaced him by Amanda Devaney. Martha recently gave notice that she will not return to work for the ACLS.

#### **GeoEd Distance Learning Portal**

Recognizing the geographically diverse nature of surveyors across Canada, the ACLS is enhancing the delivery of continuing professional development through distance learning initiatives. This includes courses offered through partnership with sister associations, academic institutions, government, and private companies and all available through the GeoEd portal.

The GeoEd portal is currently being filled by on-line courses on a variety of topics that are available at a click of the mouse. At this time there are over 130 courses available on GeoEd, These courses include live, interactive webinars but most courses are fully self-study with recorded video and other digital materials. Surveyors are able to sign up for any course and complete it at their leisure.

GeoEd is well on its way to becoming the tool that surveyors across Canada will use to make educational opportunities as easy and accessible as possible. Please visit GeoEd at: <a href="https://www.geoed.ca">www.geoed.ca</a>.

#### The Canadian Hydrographer Certification Program:

The ACLS has developed a certification model for hydrographers and offshore surveyors which has been officially recognized by the IHO/FIG/ICA International Board of Standards and Competence for Hydrographic Surveyors and Nautical Cartographers (IBSC) in April of 2016. Currently, 2 people have been awarded Certified Hydrographer Level 1 status. The ACLS program is the second internationally recognized scheme in the world.

#### **Act Amendments:**

Proposed amendments to the Canada Lands Surveyors Act and the Regulations were initiated in 2012.

The main topics addressed in the proposed amendments were:

- (a) the complaints and discipline processes of the Association;
- (b) federal labour mobility compliance (the Association is required to accept surveyors with provincial commissions for membership); and
- (c) the practices adopted by the Board of Examiners to bring its practices in line with other surveyor associations in Canada

On 3 June 2016, all Association members were invited to comment on the proposed amendments. In early August 2016, Council approved the package to be sent to the Natural Resources Minister. The package included a letter to the Minister, an explanation of all the proposed amendments and a draft Act amending the Canada Lands Surveyors Act. The package was sent to the Minister on November 2, 2016.

Amendments to the Regulations (and By-laws) concerning the same issues as the proposed amendments to the Act were completed simultaneously with the proposed amendments to the Act. They are now on hold pending approval of the proposed amendments to the Act.

# **Canadian Board of Examiners for Professional Surveyors (CBEPS):**

The ACLS continues to provide the administration and registrar services for the Canadian Board of Examiners for Professional Surveyors. The ACLS has a strong core competency in the fields of candidate management and examinations and wants to continue to make these resources available to the whole surveying community.

### Pathways to Credential Recognition of Foreign Trained Land Surveyors:

Canadian professional land surveyors are made up of 11 self-regulated professional land surveying associations across Canada, each with its own legislation and legal responsibilities. As a result, there is currently a variety of processes to assess the competence of Internationally Trained Professionals (ITPs) but no Canadian central point of contact for ITPs to obtain information and apply for credential recognition as a professional land surveyor in Canada.

The ACLS was successful in obtaining funding from Employment and Social Development Canada through the "Foreign Credential Program" and is currently at the environmental scan phase. The project is expected to be completed in the spring of 2019. The proposed project will not only investigate these matters, it will present the surveying associations with the best-case scenario for a decision which could then be implemented through a Web portal designed for foreign professionals that will provide information on the surveying profession in Canada and a roadmap for credential recognition in the various Canadian jurisdictions. It will provide all the tools required for foreign professionals to perform a self-assessment of their own credentials and what is missing and how to fill the gaps to become certified as a professional land surveyor.

At the same time, the process will provide a single point of contact for all foreign professionals wishing to enter the surveying profession in Canada which is not available at this time. Also the ability of the foreign professionals to start the process from their home country will provide them with more certainty about the process before immigrating to Canada. There will also be real possibilities that an Internationally Trained Professional may arrive in Canada with many requirements completed which may assist them in contributing to Canadian society in a shorter time.

This project is funded by the Government of Canada's Foreign Credential Recognition Program.

### ACLS Examination Enhancement Project: EEP

The ACLS has recently started a project dedicated to improving the quality of efficiency of its current examination system.

There are three objectives in achieving a more efficient examination system through the ACLS Examination Enhancement Project (EEP). These objectives are as follows:

- To provide a mechanism to allow candidates to prepare and succeed in writing the necessary examinations into four modules covering each required subject
- To update study material and fill in the gaps in the French material
- To eliminate the biannual face-to-face sitting of the examinations for candidates who do not hold a provincial surveying commission and provide greater flexibility to this entire candidate stream.

This project is expected to be completed in the Spring of 2019. ACLS's EEP has the opportunity to benefit not only stakeholders but the nation as a whole. Once implemented, ACLS members will have the ability to provide an enhanced quality of service to their clients and acquire increased comprehension of the level of need for services on Canada Lands and private lands in the Territories. In addition, this project has the capacity to increase the number of Canada Lands Surveyors available to provide survey services on Canada Lands and private lands in the Territories, which is a significant benefit to the nation over time.

#### ACLS Finance and HR Task Force

In line with a few initiatives of the Strategic Plan, the ACLS struck a task force. The mandate of the task force is to make recommendations to the ACLS Council in respect to the following strategic initiatives:

- Adopt strong financial processes to mitigate the impact of declining & volatile revenue stream(s)
- Establish an ACLS Human Resources plan that includes focus on the impact of the current ACLS workload

The task force did present some recommendations to Council and some have been acted upon. Actions so far:

- Proposed guidelines for management of the ACLS reserve funds have been implemented.
- Since the present ACLS office space is too small to house a new staff person and that the CIG space, which is an immediate neighbour to ACLS, became vacant in November, the ACLS took it over.
- The ACLS will continue to provide administrative support CBEPS.
- The ACLS will continue to maintain and improve the services provided by GeoEd.

Following our offer to provide some administrative support to the Association of New Brunswick Land Surveyors, which was rejected, the Association of Prince Edward Island Land Surveyors asked the ACLS to provide a proposal to help them out. The proposal was also rejected.

The Task Force is presently focused on staffing. The ACLS did include in the 2017 budget to hire a new staff person last September. The challenge at this time has been defining the roles and responsibilities of this new position. A decision should have been made by the time of the upcoming ACLS Annual General Meeting.

# Meetings

In 2017 the committee met by teleconference on 11 occasions: 12 and 24 Jan., 15 Mar., 26 Apr., 29 May, 20 June, 19 July, 25 Sep., 17 Oct., 9 Nov., and 5 December.

#### **Activities**

There were two major activities of the committee in 2017:

- 1. Preparation of proposed amendments to the Act.
- 2. Amendments to the By-laws (for the 2017 and 2018 annual general meetings).

### 1. Amendments to the Act (and Regulations)

Proposed amendments to the *Canada Lands Surveyors Act* and the Regulations were initiated in 2012 to address the following topics:

- (a) the Association's complaints and discipline processes (modernization);
- (b) federal labour mobility compliance (movement of surveyors among jurisdictions);
- (c) practices of the Board of Examiners (alignment with provincial practices); and
- (d) the definition of "Canada Lands Surveyor" (in the future, to be a Canada Lands Surveyor, a person will require a commission granted by the Association <u>and</u> membership in the Association).

On 4 November, 2016 a package of documents concerning the proposed amendments to the Act was sent to the Minister of Natural Resources, Canada. The package included a letter to the Minister, a draft Act amending the Act, and an explanation of all the proposed amendments. On 8 December, 2016 the Association was informed that the package had been received and that the Surveyor General Branch (SGB) had formed a group to study the proposals. The Minister acknowledged receipt of the proposed amendments on 31 January, 2017.

Although the SGB (representing the government) requested a meeting in July to discuss the proposed amendments, because of conflicting schedules and summer vacations, the first meeting with the Association was on 20 September, 2017. Representing the Association were: J-C. Tetreault and A. MacLeod; representing the SGB were J. M'Bala and Surveyor General J. Gagnon. At this meeting the SGB presented the Association with a table based on the proposed amendments and the explanation of the proposals provided by the Association. The Association was asked to complete the table by identifying issues

to be resolved by each amendment as well expected outcomes and provincial practices. The Surveyor General asked the Association to review the entire Act to identify additional issues and provisions that could be removed. The objective of this request was to ensure that the Act would not require additional amendments in the near future.

At a second meeting on 28 September, the Association returned the table presented at the first meeting more or less complete except for provincial references. In response to the Surveyor General's request, it also presented a partially completed new table that identified every subsection of the Act (including the proposed amendments) with a justification for why it should remain or be in the Act. The table included proposed additional amendments. The SGB representative (J. M'Bala) accepted the work that had been done. The Association asked how far the government was willing to go with amending the Act because the Association had restricted the initial proposed amendments to certain topics even though it was aware of other issues with the Act. The Association was invited to make additional proposals.

A third meeting took place on 28 November with the same representatives. The two tables mentioned previously (completed by the Association and submitted in early November) were reviewed. The need for comparisons with provincial legislation was discussed as were the Association's proposals for additional amendments. At a meeting on 20 December the SGB added a representative (M. Gingras). There was a review of what had been done to date; a review of the two tables; a more detailed discussion of additional amendments including proposed amendments to the *Canada Lands Surveys Act*; and an examination (by provision) of the proposed Act based on the justification table prepared by the Association. About 25% of the provisions were examined. The next meeting is scheduled for 17 January, 2018. Legal counsel has not been involved in the meetings yet.

The present target is to complete this round of discussions (including legal counsel involvement) with the SGB by June or, at the latest, September, 2018. After approval of the proposals by the Council (and agreement between the Association and the SGB) there will probably be a new submission to the Minister. That submission would be used by the SGB with the Department of Justice legislative drafters.

Proposed amendments to the Regulations are on hold pending approval of the proposed amendments to the Act. However, they are being updated to match proposals for the Act.

#### **2a. By-laws amendments** (presented at the 2017 annual general meeting)

Four proposed amendments to the By-laws were presented at the 2017 annual general meeting:

- 2017-01: re Part 10 (Committees) (and 11 (Fees, Dues, Levies)) to better identify and authorize committees that have regulatory responsibilities, and to standardize the description of all committee operations (with the amendments described in 02 and 03 below, the current content of Part 11 is moved to Parts 9 or 12, and Regional Group provisions are moved from Part 10 into a new Part 11);
- 2017-02: re Part 9 (Licenses) to move licensing provisions from Part 11 into Part 9, and to better define continuing professional development and licensing provisions;
- 2017-03: re Part 12 (Levies and Fees) to move dues and fees provisions from Part 11 into Part 12; and
- 2017-04: re Part 12 for fee changes to prepare for the retirement of the Executive Director.

At the meeting suggestions were made concerning the continuing professional development requirements presented in 2017-02 and there was a discussion of preparations

for the retirement of the Executive Director (2017-04). (A suggestion concerning Part 5 (Financial Matters) was addressed in the proposed amendments for the 2018 annual general meeting.) After the meeting this committee revised proposed amendments 2017-02 and 04. Council decided not to make any changes to 2017-02 but revised 2017-04 again. The proposals were submitted to vote by members and were subsequently approved. They came into effect on 1 August, 2017 and 1 January, 2018 (dues and fees).

# **2b. By-laws amendments** (for presentation at the 2018 annual general meeting)

As part of its on-going review of the By-laws, the committee prepared the following proposed amendments for presentation at the 2018 annual general meeting:

- 2018-01: re Part 2 (Name, Languages, Head Office, Seal), re-organization of Association features into Part 2, re-naming the Part, seals, a move of section 5.9 into Part 2;
- 2018-02: re Part 3 (Officers of the Association), terms of office, succession, consequential amendments to Part 4 (Council);
- 2018-03: re Part 5 (Financial Matters), re-organization, budgets, language;
- 2018-04: re Part 8 (Membership), criteria for registering members; and
- 2018-05: re Part 9 (Licences), licensed member's seal, a move of subsection 2.4(2) into Part 9.

Council proposed another amendment (2018-06) re Part 12 (Dues, Fees and Levies) to address concerns about the fee collected by the Association for membership in *Professional Surveyors Canada*. After consideration by this committee, it was suggested that the current provision provided Council with the authority to do what it wished to do with the fee. The proposal was withdrawn.

After consideration, Council directed that proposed amendments 2018-03, 04 and 05 be postponed to a later date; 2018-01 was initially approved and then put under additional review; and 2018-02 was placed on hold pending review of issues that Council had with one provision. As a result of the postponement of 2018-05, certain provisions of that proposal were moved to 2018-01 as a consequential amendment in order to maintain the integrity of the By-laws.

As of 10 January, 2018, the following proposed amendments are still under consideration for presentation at the 2018 annual general meeting:

- 2018-1: re Part 2 (Name, Languages, Head Office, Seal), re-organization of Association features into Part 2, re-naming the Part, seals, a move of section 5.9 into Part 2, consequential amendments to Part 5 (Financial Matters) and Part 9 (Licenses); and
- 2018-2: re Part 3 (Officers of the Association), terms of office, succession, consequential amendments to Part 4 (Council) and Part 13 (Miscellaneous Matters).

Council finally decided that more work was required on the 2018 amendments, so postponed presentation to the membership to a future AGM.

### Plans for 2018-2019

- 1) Respond to government concerns with proposed amendments to the Act.
- 2) Proceed with amendments to the Regulations, once approval of the proposed amendments to the Act has been received.
- 3) Review of the By-laws and the preparation of amendment proposals (possibly including amendments that may be required by the proposed amendments to the Act and Regulations).

- 4) Review of "not-for-profit" corporate by-law requirements to ensure that there is compliance through provisions in the Act, Regulations and the Association's By-laws
- 5) Respond to requests from Council.

#### OFFSHORE INFRASTRUCTURE SURVEYS- TASK FORCE

The Offshore Infrastructure Surveys – Task Force (OIS-TF) was struck to examine the current legislation with respect to offshore infrastructure being used by the provinces and overseas specifically with respect to offshore pipelines, flowlines, umbilicals, subsea structures, and communication and power cables. After some initial research, the Task Force realized that further detailed research was needed to establish a proper Terms of Reference. A draft report will be presented at CHC 2018.

A total of three (3) GoToMeeting conference calls were held respectively on 08 June, 28 September and 24 November 2017 to review the research to date and discuss the results.

The information in the report will help populated the Marine Spatial Data Infrastructure (MSDI) as well as inform practitioners and users of Canada's offshore about the complex nature of that space. The need for proper surveys, irrespective of whether Crown real property rights are involved, are paramount to ensuring the success and proper operation of offshore operations. Whenever possible a qualified Canada Lands Surveyor should be involved in such work, and hopefully onsite during any offshore surveys to ensure the necessary and correct observations are made and to help ensure the proper installation of any offshore pipelines, flowlines, umbilicals, subsea structures, and communication and power cables.

Once the report has been completed it will be forwarded to the ACLS Offshore Committee for review. The report will be used to generate various recommendations for the better governance of the offshore via the ACLS Offshore Committee which will be forwarded the ACLS Council for approval and then sent onto the Surveyor General for review and action.

# DISCIPLINE COMMITTEE ANNUAL REPORT

A complaint was referred to the discipline committee in late 2016. A five member panel of discipline committee members was formed to deal with the matter. Thanks to the cooperation of all parties the hearing took place by teleconference. The panel found the member guilty as charged and levied a combination of fines, costs and suspension against the member and his employer.

Julia is working on a best-practices document in cooperation with the Standards Committee, and provincial practice review managers.

#### **MYCLSS/Electronic Plan Checklist**

The Surveyor General's department continues to restrict its plan reviews to critical issues only. It is the sole responsibility of the surveyor to ensure that a plan complies with the General Instructions in all other respects.

#### 2017 Prime Objectives

This past year and beyond we are focusing on engaging the membership by consciously targeting specific membership groups. We have asked what we can do for each membership group to enable them to reach their professional development goals. We can achieve this by grouping the membership by scope of practice and by geographic region.

#### **Activities:**

The committee held six meetings in 2017 and hosted two meetings of the GeoEd Advisory Panel and a focus group meeting to brainstorm about the direction we should go with GeoEd.

The Aboriginal Liaison Committee (ALC) held numerous teleconference meetings in 2017 - 2018. The committee members are listed above. The Committee makeup changed, as Leona Irons (NALMA), Ibrahim Kalown (INAC) and the Surveyor General left the group in 2017. Thanks, are extended to all of the committee members for their commitment. We would also like to recognize ACLS office staff for their ongoing support.

We think that there continues to be good reason and support for this committee, both internally (educating ACLS members) and externally (creating new resources and making available existing resources for First Nations). The potential activity for the committee is almost limitless. And two Working Groups were established to focus on specific activities. But, we admit that the Aboriginal Liaison Committee and both Working Groups are struggling to be effective.

At the ACLS Council face-to-face meeting on November 16 & 17, 2017, in Ottawa, Council reviewed the 2014 Strategic Plan. The Aboriginal Liaison Committee's (ALC) work/tasks were

thoroughly discussed and it was decided that the ALC had too many tasks from the Strategic Plan to address.

Accordingly, Council decided to reformat the Committee and established an Indigenous Relations Steering Committee (IRSC) with a more task focused approach, by having the IRSC form Strategic Working Groups (SWG) of 3 to 5 members (depending on the task) to complete the specific assignments, as they directly relate to the Strategic Plan. The ISRC will develop and oversee: the listing of the specific projects, the assignment of the tasks and the formation of each task group and ensure there are timeframes established and met for each SWG.

# **Indigenous Relations Steering Committee (IRSC) Formed**

Council assigned the following ACLS members to the Steering Committee: Tania Bigstone, ACLS President & LAB-RC (East); Bob Fligg, Surveyor General Branch (Central); Andrew Christian, Private Industry (West); and, Joe Iles, Private Industry (North) — with Joe continuing as Chair of the new Committee. The IRSC was specifically designed with members from the ACLS, Surveyor General Branch, private Industry, and to be regionally representative.

By assigning smaller groups to complete tasks, we hope the Committee will be able to accomplish more items on the Strategic Plan, than we have been able to in the past.

Specific Activities of the Indigenous Relations Steering Committee since being established include:

- Submitted Terms of Reference for the new Steering Committee to Council on February 13, 2018, for their approval.
- Developed Scope of Work for a Strategic Working Group to follow-up on the Cost Study Final Report.
- Communique to membership advising of change from ALC to IRSC and requesting volunteers for Cost Study Strategic Working Group. (February 12, 2018)
- A major activity of this group has been development of a ½ day seminar for our members and guests at the National Surveyors' Conference 2018.

With the implementation of Canada's Hydrographic Surveyors Certification Program in April 2016, the committee worked towards promoting the program through various media and meetings. The committee has also continued to engage with NRCan Surveyor General Branch and Fisheries and Oceans Canada on the promotion of Canada's Marine Cadastral Layer within the Marine Spatial Data Infrastructure (MSDI). Also of note was the formation of a task force on Offshore Infrastructure Surveys.

#### **Task Force on Offshore Infrastructure Surveys**

As a means towards identifying opportunities for improvement with how spatial information describing offshore infrastructure is gathered, managed and shared, the Offshore Infrastructure Surveys – Task Force (OIS-TF) was struck to examine the current legislation with respect to offshore infrastructure being used by the provinces and overseas specifically with respect to offshore pipelines, flowlines, umbilicals, subsea structures, and communication and power cables. A draft report will be presented at CHC 2018.

A total of three (3) GoToMeeting conference calls were held respectively on 08 June, 28 September and 24 November 2017 to review the research to date and discuss the results.

It is anticipated the information in the report will promote integration of offshore infrastructure data within Canada's Marine Spatial Data Infrastructure (MSDI) as well as inform practitioners

and users of Canada's offshore about the complex nature of that space. Research thus far has underscored the need for proper surveys, irrespective of whether Crown real property rights are involved, as paramount to ensuring the success of offshore operations; further the role of the Canada Lands Surveyor in offshore surveys to ensure the necessary and correct observations are made to specific standards to help ensure the proper installation of any offshore pipelines, flowlines, umbilical lines, subsea structures, and communication and power cables.

Once complete, the report will be forwarded to the ACLS Offshore Committee for review. The report will be used to generate various recommendations for the better governance of the offshore via the ACLS Offshore Committee which will be forwarded the ACLS Council for approval and then sent onto the for further consideration by the Surveyor General for review and action.

#### **MSDI**

The committee learned more about the development of Canada's MSDI with emphasis on the Marine Cadastre application, by way of a virtual presentation given by Claude Guy of the Canadian Hydrographic Service, Department of Fisheries and Oceans. Details and preliminary results from a pilot project focusing on three locations: Bay of Fundy, Beaufort Sea and Dixon Entrance were further explained along with requirements to align data formats with international standards: IHO S-121 an ISO 19152.

#### **CBEPS Interaction**

Approval for changes to the Canadian Board of Examiners for Professional Surveyors (CBEPS) core syllabus item C12 Hydrographic Surveying and the new elective syllabus item E2 Advanced Hydrographic Surveying was affirmed earlier in the year. The OC chair participated in a CBEPS audit of York University's Geomatics Engineering Program in which York U's Hydrography Course was evaluated against C12 syllabus study notes.

#### National Surveyors Conference-Canadian Hydrographic Conference 2018

To assist with the development of the NSC-CHC 2018 technical program, the committee reached out to several authors and organizations. Four joint sessions: Professional Development and Education; Hydrography and Policy Developments; Geodesy and Hydrography; and Practical Hydrography were arranged.

#### **ACLS Canadian Hydrographer Certification Scheme**

The committee served to promote the scheme through various media and meeting and event venues. Research and collaboration was begun with the Surveying and Spatial Sciences Institute of Australia towards establishing mutual recognition between Canada and the Australasian Hydrographic Surveyor Certification Scheme. As an aid for candidates, an inventory of learning resource including distance learning courses in hydrographic surveying was prepared. A report from the Canadian Hydrographer Certification Panel (CHCP) has been submitted separately from this report.

#### **R/V David Thompson**

As a side bar to this report, ACLS members may be interested that Parks Canada Agency has recently commissioned a 228 tonne research vessel, equipped with a shallow-water multi-beam sonar system, named in honour of one of Canada's pioneer surveyors, David Thompson. The former DFO-CCG Mid-shore fishery patrol vessel will be used to support underwater, archeological surveys on all 3 coasts, including the Great Lakes. Bathymetric data acquired from
